**Definition included:** Social work is a practice-based academic discipline that addresses the basic needs of individuals, families, groups, communities and society as a whole in order to improve individual and collective well-being. The practice of social work draws on areas such as psychology, sociology, health, political science, community development, law and social economy and engages in public policy systems to develop interventions and improve social functioning and social responsibility. The practice of social work is normally divided into three levels. Micro- work involves working directly with individuals, the family, such as providing individual counseling / therapy or helping the family to address its core functions. Interim work involves working with social groups and communities. Macro-work involves promoting change on a larger scale through advocacy, social policy, research development, public service administration or cooperation with government institutions. An integral part of social work as an academic discipline is the management of social services and social assistance facilities at micro - meso -macro levels. The implementation of scientific research in social work is a special way of cognition that systematically collects and categorizes the facts on the basis of which innovative theories are created .

The knowledge, skills and competencies of the graduate of the habilitation procedure in the field of social work are a prerequisite for the academic and scientific employee to be a recognized leader in the relevant field of the habilitation procedure by his / her scientific works and his / her works or works of art. . He is able to lead doctoral students and other scientific and research teams. He is a recognized scientific figure in professional circles at the domestic and foreign scientific level.

### **3. Level of criteria for evaluating the fulfillment of conditions for obtaining the title of associate professor**

The general criteria for obtaining the title of associate professor and professor at Comenius University in Bratislava are incorporated into

Internal Regulation No. 24/2021, which was approved by the Scientific Council of Comenius University in Bratislava in accordance with § 12 par. 1 letter e) of Act no. 131/2002 Coll. on Higher Education Institutions and on Amendments to Certain Acts, as amended. The framework criteria set out the minimum criteria for evaluating the fulfillment of the conditions for obtaining the scientific pedagogical title "associate professor" (hereinafter abbreviated as "criteria for obtaining the title of associate professor") and the minimum criteria for evaluating the fulfillment of the conditions for obtaining the scientific pedagogical title "professor" (hereinafter abbreviated "criteria for obtaining the title of professor "). Meeting the minimum criteria approved by the Scientific Council of Comenius University is a necessary condition for obtaining the title of associate professor or professor. The framework criteria of the Comenius University are based on ideas about the structure of personalities of applicants for these degrees, take into account the need for their presentation and promotion in the international scientific forum, and take into account the scientific focus and orientation of publishing activities of individual faculties and departments of habilitation and inauguration proceedings.

#### **4. Rules and procedures of the habilitation procedure**

Comenius University in Bratislava has developed rules and procedures for the habilitation procedure and the inauguration procedure in Internal Regulation no. 25/2021, which was approved by the Scientific Council of Comenius University in Bratislava.

The rules for creating Habilitation and Inauguration procedure are in accordance with:

- a) generally binding legal regulations, which are the Act on Quality Assurance, Act no. 131/2002 Coll. on Higher Education Institutions and on Amendments to Certain Acts as Amended (hereinafter referred to as the "Higher Education Institutions Act"), Decree of the Ministry of Education, Science, Research and Sports of the Slovak Republic (hereinafter referred to as the "MŠVVŠ SR") no. 246/2019 Coll. on the procedure for obtaining scientific-pedagogical titles and artistic-pedagogical titles of associate professor and professor (hereinafter referred to as the "Decree on Habilitations and Inaugurations"), Decree of the Ministry of Education, Science, Research and Sport of the Slovak Republic no. 244/2019 Coll. on the system of study fields in the Slovak Republic, Decree of the The Ministry of Education, Science, Research and Sport of the Slovak Republic No. 16/2016 Coll., which establishes professional organizations whose members exercise a regulated profession . 296/2010 Coll. on professional competence for the performance of the medical profession, the method of further education of medical staff, the system of specialized departments and the system of certified work activities, as amended.
- b) with the Standards for the habilitation procedure and the procedure for the appointment of professors (hereinafter referred to as "standards") published by SAAVŠ, which define a set of requirements, the fulfillment of which is conditional on granting accreditation to Habilitation and Inauguration procedure at universities in the Slovak Republic.

According to Art. 8 of the Internal Regulation No. 25/2021 has rules and procedures of the habilitation and inauguration procedure the Comenius University in Bratislava has established and publicly accessible rules and procedures of the Habilitation and Inauguration procedure, which are in accordance with generally binding regulations. The Comenius University in Bratislava rules and procedures guarantee:

- a) transparency and openness of procedures under the same conditions for all tenderers known to them in advance,
- b) impartial, objective, professionally based, consistent and unambiguous verification of the fulfillment of the set requirements and criteria by the applicant,
- c) that the proven academic fraud of the applicant is a reason for not awarding the title of associate professor or not awarding the title of professor,
- d) selection and composition of members of the habilitation commission and members of the inaugural commission and opponents of Habilitation and Inauguration procedure in accordance with generally binding regulations,
- e) that the members of the habilitation commission and the members of the inauguration commission, and opponents of the Habilitation and Inauguration procedure act in the relevant department of the Habilitation

Proceeding or in justified cases in the field of science, technology and art according to the applicant's creative activity.
